The President today announced his intention to nominate Diana Lady Dougan, of Utah, as Coordinator for Communications and Information Policy, Department of State, with the rank of Ambassador. This is the first such appointment to be made under the provisions of Section 124, Public Law 98-164 of November 22, 1983.

Mrs. Dougan was Assistant Chief Clerk of the Maryland State Legislature in 1964-1965. In 1964-1966 she was Telecommunication and Public Relations Consultant in Washington, D.C., and New York. She was CATV Marketing and Promotion Director at Time, Inc., in New York City (1964-1968), and did personal investments and consulting work (primarily pro bono), and was a Partner with Dougan Associates in Salt Lake City, Utah (1969-1983). In 1976-1983 she served in a Presidential appointment as Director of the Corporation for Public Broadcasting in Washington, D.C., and also as a Member of the Utah State Telecommunications Task Force. In 1978-1983 she was a Member of CER gubernatorial Commission to reorganize the Executive Branch of the Utah State Government. Since 1983 she has been Coordinator for International Communications and Information Policy (accorded the personal rank of Ambassador in April 1983), Department of State. This position was a Secretarial appointment until established as Presidential with Senate confirmation.

Mrs. Dougan graduated from the University of Maryland (B.A., 1964). She attended the University of Utah (1969-1970) and Harvard University (1979). Her foreign languages are some knowledge of French and Spanish. She was born January 13, 1943 in Dayton, Ohio.

The President today announced his intention to nominate Richard Wood Boehm, of the District of Columbia, a Career Member of the Senior Foreign Service, Class of Minister-Counselor, as Ambassador to the Republic of Cyprus. He would succeed Raymond C. Ewing.

Mr. Boehm served in the United States Army in 1944-1946. In 1950-1951 he was a Proofreader and Editor with the Prentice-Hall Publishing Company, and was in Junior Management with the Mutual Life Insurance Company of New York in 1951-1955. In 1955 he entered the Foreign Service as Press Officer in the Department. He was Consular Officer in Naha, (1956-1958), Economic Officer, Staff Officer, then Political Officer at the United States Mission in Berlin (1958-1962). In the Department, he was Intelligence and Research Analyst (1962-1965) and NATO Political Affairs Desk Officer (1965-1966). He was Deputy Chief of Mission in Luxembourg (1966-1968) and attended the National War College in 1968-1969, and was in the Department as Public Affairs Adviser in the Bureau of Economic Affairs in 1969-1971. He was Counselor of Embassy for Mutual Security (Political-Military) Affairs in Ankara (1971-1974), and Counselor of Embassy for Political-Military Affairs in Bangkok (1974-1976). In 1976-1977 he was Diplomat in Residence at Hamilton College in Clinton, New York. He was a Foreign Service Inspector in the Department in 1977-1978. He was Deputy Chief of Mission in Kathmandu (1978-1980), and in Ankara (1980-1983). In 1983 he was an Adviser with the United States Delegation to the United Nations General Assembly in New York City. Since 1984 he has been Deputy Examiner of the Board of Examiners for the Foreign Service in the Department.

Appointment of John F. W. Rogers to the
Advisory Council on Historic Preservation

I have reviewed the Personal Data Statement submitted by John F. W. Rogers in connection with the above-referenced prospective appointment, and have no objection to proceeding with the appointment. The functions of the Advisory Council on Historic Preservation include advising the President and Congress on historic preservation, promoting private sector interest in historic preservation, advising states and localities concerning historic preservation legislation, reviewing the pertinent programs and policies of Federal agencies, and preparing an annual report on Council activities. The composition of the Council is specified in 16 U.S.C. § 470i(a) and includes "the Secretary of Agriculture and the heads of four other agencies of the United States, the activities of which affect historic preservation, appointed by the President."

In a memorandum to you dated June 18, 1984, Mr. Garrett concluded that the Office of Administration (OA) is an "agenc[y] of the United States" and that Mr. Rogers could be considered the "head" of that agency, even though Reorganization Plan No. 1 of 1977, establishing OA, specified that it "shall be headed by the President." You advised John Herrington on June 18 that the President could appoint the Director of OA to this Council. In light of this advice the only remaining question is whether anything on Mr. Rogers' PDS precludes his appointment. Mr. Rogers represents the President on the Board of Trustees of the U.S. Capitol Historical Society and is a member of the Board of Trustees of the National Building Museum. It is remotely conceivable that these associations could present a conflict of interest at some point with respect to a particular matter before the Council, in which case Mr. Rogers will be required to recuse himself, but in light of the general advisory functions of the Council the associations hardly present a hurdle to his appointment.

Appointments of Albert Anderson, Jerry Larson, James Bopp and Reappointments of Lee Christoferson and Ruth Warson to the President's Committee on Mental Retardation

I have reviewed the Personal Data Statements submitted by the above-named individuals in connection with their prospective appointments or reappointments to the President's Committee on Mental Retardation (PCMR). The PCMR, established by Executive Order 11776, provides advice to the President on mental retardation, Federal programs in the area, and the development and dissemination of information on mental retardation. The PCMR submits an annual report to the President on mental retardation.

Pursuant to section 2 of Executive Order 11776, several Cabinet members serve on the Committee ex officio, and the President may appoint "[n]ot more than twenty-one other members...employed in either the public or the private sectors...includ[ing] specialists in medicine and other healing arts, human development, special education, law, and employment problems, as well as members of foundations and other private organizations active in the mental retardation field."

Jerry P. Larson is a social worker from Chicago, employed by the State of Illinois as director of a mental health rehabilitation program. Ruth Warson is a clinical nursing instructor with a background in special education; she is being reappointed to the Committee. Albert LeRoy Anderson is a pediatric dentist from San Diego. While this does not of itself suggest any particular qualification for the PCMR, Mr. Anderson has served on several medical and health boards with broader responsibilities than pediatric dentistry, including Governor Reagan's state advisory health council. Nothing in the PDSs of Larson, Warson, or Anderson presents any difficulties.

Lee A. Christoferson is a physician and chairman of the Department of Neurology Science at the University of North Dakota. He indicates on his PDS that he testified for the defense against his friend Senator Mark Andrews (R-ND) in

the somewhat celebrated medical malpractice suit brought by Andrews after the death of his wife. Although this may affect Christoferson's relationship with Andrews it does not appear to present any obstacle to his reappointment to this Committee.

James Bopp was recently (February 1984) cleared by Mr. Garrett for a PAS position as a member of the National Advisory Council on Women's Educational Programs. A copy of the clearance memorandum is attached, indicating that Mr. Bopp has been active in the right-to-life movement and may attract some controversy on that score. 

Appointments of Larry Zarian, Tommy L. Tabor, William H. Taggart, Frank Ursomarso and Reappointments of Russell I. Brown, Joanne C. Kozberg, Michael L. Johnson, and Stuart J. Northrup

I have reviewed the Personal Data Statements submitted by the above-referenced individuals in connection with their prospective appointments or reappointments to the National Highway Safety Advisory Committee (NHSAC). Pursuant to 23 U.S.C. § 404(a)(1), the President may appoint 35 members of NHSAC. The statute provides that the appointed members "shall be selected from among representatives of various State and local governments, ... of public and private interests contributing to, affected by, or concerned with highway safety, and of other public and private agencies, organizations, or groups demonstrating an active interest in highway safety, as well as research scientists and other individuals who are expert in this field."

Of the prospective reappointees, Mr. Johnson is a county coroner, Mr. Ursomarso owns and manages a large automobile dealership, Mrs. Kozberg serves on the board of the Coro Foundation (in which capacity she initiated a study of the Los Angeles urban transit system), and Mr. Brown owns a consulting firm specializing in planning, administering, and evaluating public safety programs. All four continue to satisfy the statutory requirements for appointment to this committee. The act creating the NHSAC prohibits reappointment of any member who has served a three-year term, within one year following the end of his preceding term. 23 U.S.C. § 404(a)(2)(A). These four individuals were appointed on June 28, 1982, to fill the remainder of terms expiring on March 15, 1984. Since they have not served a full three-year term, the limited ban on reappointments does not apply to them. The ban arguably would apply if they continued to holdover past June 28, 1985, since they would then have served three years: just under two years of a term and the rest as holdovers. Since Presidential Personnel can move slowly, we should -- in what is probably an excess of caution -- advise that office that these reappointments must be made before June 28, 1985.

Of the new appointees, Mr. Taggart is active in the San Diego County Safety Council, Mr. Zarian serves on the Glendale City Council, Mr. Northrop is Chairman of the Huffy Corporation (world's largest manufacturer of bicycles), and Mr. Tabor is a Memphis policeman and former President of the Afro-American Police Association. All of the prospective new appointees satisfy the statutory requirements for appointment to the Committee.

I have reviewed the Personal Data Statements submitted by the above-referenced eight individuals, and have no objection to proceeding with these appointments and reappointments. I have not yet received a PDS from Carl Jefferson.
