The President's Commission on Industrial Competitiveness was established by Executive Order 12428 (June 28, 1983). The purposes of the Commission are to review means of increasing the competitiveness of United States industry, with particular emphasis on high technology, and provide appropriate advice to the President. The Commission was established in such a fashion that its members from the private sector would not be considered government employees for purposes of the conflicts laws. Thus, members are not paid for their services and those from the private sector "shall represent elements of industry, commerce, and labor most affected by high technology, or academic institutions prominent in the field of high technology." Under the executive order, members must also "have particular knowledge and expertise concerning the technological factors affecting the ability of United States firms to meet international competition at home and abroad."

Mr. Noyce is Vice Chairman of Intel Corporation and has an extensive background in the high technology field. He clearly satisfies both the representative and expertise prerequisites for appointees to the Commission. Mr. Hardage has degrees in engineering and business administration, and has been active in the real estate, construction, and mobile home fields. These fields are less obviously affected by high technology, but Mr. Hardage may nonetheless be considered to satisfy the executive order prerequisites, broadly construed. Mr. Samuel is the President of the Industrial Union Department, AFL-CIO, and may be appointed as a labor representative. Mr. Regan is Comptroller of New York, and accordingly is not being appointed as representative of the private sector. Messrs. Noyce, Hardage, and

Samuel have numerous high technology holdings and affiliations, but since they are being appointed in a representative capacity these do not present a hurdle to their appointments. Mr. Regan has no holdings or affiliations that present a conflict of interest.

I have not yet received a PDS from Robert Baldwin.

The President's Commission on Industrial Competitiveness was established by Executive Order 12428 (June 28, 1983). The purposes of the Commission are to review means of increasing the competitiveness of United States industry, with particular emphasis on high technology, and provide appropriate advice to the President. The Commission was established in such a fashion that its members from the private sector would not be considered government employees for purposes of the conflicts laws. Thus, members are not paid for their services and those from the private sector of industry shall represent elements of industry, commerce, and labor most affected by high technology, or academic institutions prominent in the field of high technology." Under the Executive Order, members must also "have particular knowledge and expertise concerning the technological factors affecting the ability of United States firms to meet international competition at home and abroad."

Mr. Baldwin retired as Chairman of the Board of Morgan Stanley Inc. on December 31, 1983, but will continue as a consultant to Morgan Stanley during his retirement. His education and experience satisfy the expertise requirements of the Executive Order, and both his prior service and continuing association with Morgan Stanley permit him to be considered representative of an element of commerce deeply affected by high technology. In light of the structure of the Advisory Committee, Mr. Baldwin's associations and holdings do not represent a conflict of interest. I have reviewed Mr. Baldwin's PDS and have no objection to proceeding with this appointment.

Tax Credits, Easing of Antitrust Barriers Are Urged to Boost U.S. Sales Overseas

WASHINGTON—A presidential commission recommended permanent tax credits for industrial research and the removal of certain antitrust barriers to make U.S. products more competitive world-wide.

Mr. Reagan's Commission on Industrial Competitiveness steered clear of the more fashionable alternatives requiring direct federal aid to industries. "We may look at the so-called industrial-policy issues later on but for now these are what our members consider most important," Eglis Milbergs, the panel's executive director, said.

The 39-member commission, made up almost entirely of private-sector representatives, also is urging stronger protection of industrial patents and tighter laws against counterfeit products entering the world market. These recommendations have been submitted to a cabinet council headed by Commerce Secretary Malcolm Baldrige; the council could send the recommendations to the White House for its endorsement.

John Young, chairman of Hewlett-Packard Co. and head of the president's commission, said its initial recommendations focused on research, patents and copyrights because these are "key factors" in preserving the U.S. technology edge.

The eight recommendations issued by the seven-month-old panel generally are compatible with Mr. Reagan's pet ideas about freeing private enterprise from unnecessary legal hindrances.

Specifically, the panel wants to modify the antitrust laws to enable several companies to engage freely in collective research. Several U.S. companies have done that by investing in a research venture called Microelectronics Computer Corp. But they had to obtain a Justice Department exemption from antitrust liability; any new product or process that the venture yields also will require further exemptions before the investors can use it commercially.

The antitrust relief that the panel seeks is similar to features in a Senate bill supported by the administration.

The commission also is urging legislation that would make tax credits for corporate research a permanent fixture. U.S. companies currently enjoy such tax breaks under the Economic Recovery Act of 1981, but these expire next year.

The commission also recommended that the Commerce Department set up a data bank that would pull in marketing information from U.S. industries and overseas markets. Mr. Baldrige's aides said the department already has a computerized system for

collecting such trade data that is close to providing the kind of service sought by the commission.

The aides also said that the merger of most of the Commerce Department's Bureau of Industrial Economics into its International Trade Administration also may satisfy commission suggestions.

I have reviewed the Personal Data Statements submitted by Elizabeth M. Hanicke, David Myers and Vito P. Battista in connection with their prospective appointments to the Architectural and Transportation Barriers Compliance Board. This Board monitors compliance with Federal rules governing access for the handicapped, and investigates alternative approaches to architectural, transportation, and attitudinal barriers that impede the mobility of the handicapped. The President is authorized to appoint eleven members of the Board by 29 U.S.C. § 792(a)(1)(A). That provision specifies that five of the eleven "shall be handicapped individuals."

David W. Myers, who has served on the Board since January 18, 1981, is to be reappointed to another three-year term. The statute specifies that no member appointed from the general public "may be reappointed to the Board more than once unless such individual has not served on the Board for a period of two years prior to the effective date of such individual's appointment." Mr. Myers has not previously been reappointed to the Board, so he is eligible for reappointment. He serves as Executive Director of the Louisiana Commission for the Deaf, and is handicapped. I have reviewed his PDS and see nothing that would present conflict of interest problems.

Vito P. Battista is an architect, director of the Institute of Design and Construction, and has been active in local urban planning activities. The Institute is a school for the architectural trade, educating draftsmen, designers, estimators, etc. I do not consider Battista's association with such an educational institution to present a conflict with his activities as a member of this Board, nor is there anything else in his PDS that raises concerns.

Betty Hanicke is the Secretary and Treasurer of P.W. Hanicke Mfg. Co., a company that produces artificial limbs. She is

a certified orthotist, and has been extensively involved in orthotic and prosthetic affairs. The fact that Mrs. Hanicke is employed by a company producing artificial limbs, which has a contract with the U.S. Government (Veterans Administration), does not present a conflicts problem. The Board's duties focus on architectural and transportation barriers confronting the handicapped, rather than the provision of artificial limbs or other personal aids for the handicapped.

Neither Battista nor Hanicke indicate that they are handicapped, but they are replacing non-handicapped members of the Board so the requirement that five of the eleven members appointed from the general public be handicapped is still satisfied.

I have not yet received a PDS from Nackey Scripps Loeb.

SUBJECT: Appointments of Willa Ann Johnson and Maudine R. Cooper to the President's Commission on White House Fellowships

I have reviewed the Personal Data Statements submitted by Mesdames Johnson and Cooper for appointment to the President's Commission on White House Fellowships. The Commission was established by Executive Order 11183, as amended. The President is authorized to appoint to the Commission "outstanding citizens from the fields of public affairs, education, the sciences, the professions, other fields of private endeavor, and the Government service." Both Johnson, a Senior Vice President of the Heritage Foundation, and Cooper, Vice President of the National Urban League, would seem to qualify. (This morning's Post carried a story that Cooper would be nominated by Mayor Barry to be the Director of the D.C. Office of Human Rights. I see no way in which this would affect her appointment to the Commission.)

Neither Johnson's nor Cooper's PDS revealed any conflicts that would preclude their appointments. I would point out, however, that Cooper has been a virulent critic of the Administration's civil rights policies. Those in favor of this Presidential appointment for Ms. Cooper should consider whether such an honor will give added credibility to her highly critical charges.
