



New Agenda for Reagan . . .

The Tower Commission report hit the White House with hurricane force, and the debris is deep. The commission's judgment that the Iran-*contra* scandal was not the system's fault but that of President Reagan's nonchalant approach to affairs of state represents a personal and brutally public failure for the President. It must not, and need not, become a national failure for Americans who twice sent him to the White House, reassured by his confident smile.

The first act of clearing away the debris came swiftly, with the replacement of Donald T. Regan as chief of staff and the appointment of Howard H. Baker Jr., former Senate majority leader. The next step is finding a mix of policy ventures that will not leave the damaged President and the nation drifting through the nearly two years left of his term.

The new agenda must acknowledge that there is only the slightest chance that the President will change his ways—will, as even close friends have counseled, snap out of it and take control. Nor can the White House staff pull him through with staged media events that would follow Willie Loman's axiom that the most important thing is making a good impression.

The policy question that looms over all others for the President, the nation and the world is how to reduce the danger that the competition between the United States and the Soviet Union for world leadership will branch off into war—nuclear or otherwise. The Soviets are losing the peaceful competition—witness the struggle of General Secretary Mikhail S. Gorbachev to shake life into his giant bureaucracy.

The President's breakdown in leadership came over something so far-fetched—establishing better relations with Iran, a nation committed to terrorism—that even success would hardly have mattered. If Reagan concentrates, as even political opponents say that he can do when he wants to, he can take the lead in producing something that every thinking person on Earth yearns for—a new arms-control treaty to replace the one that he has already discarded and salvage the one surviving treaty that his defense secretary, Casper W. Weinberger, is so anxious to scuttle.

Even hard-liners in the Administration believe that agreement on a far-reaching arms-control treaty is within his grasp if the President will only reach for it. The basic ingredients for a treaty are in sight on the bargaining table in Geneva: major reductions in the heaviest and most destructive missiles, withdrawal by both sides of the hair-trigger missiles with Europe in their sights, and a treaty that can harness, if not block altogether, the catapulting of the nuclear-arms race into outer space. Domestic policies need to provide a minimal distraction for the embattled White House. Reducing the enormous national debt is crucial, but Congress will have the last word on the budget this year, as it had last year. The same is true for welfare reform and long-term health insurance for the elderly—both of which are already before Congress.

The President can make a fresh start. But the clock is running on arms control, and an agreement will require his undivided attention and personal intervention.

... Good Start, ^{Sen Baker a perfect} Good Choice choice

The imperative facing President Reagan to reorganize and reinvigorate his White House staff while trying to restore his shaken political standing has at least begun well. In naming Howard H. Baker Jr. as his new chief of staff, Reagan has turned to an experienced political figure whose service in the Senate, culminating in four years as majority leader, won him the respect of his peers. Baker, a Republican from Tennessee, retired from the Senate two years ago. His voting record there was that of a Reagan loyalist, but he is also—as his investigatory role during the Watergate scandal a dozen years ago showed—a man of independent judgments. He should be able to help a President who desperately needs all the help that he can get.

The replacement of Donald T. Regan as chief of staff comes many months late. Indeed, it has long been apparent that he should never have served in the White House in the first place. His move there

at the beginning of Reagan's second term came about, typically, through the manipulation of a passive President. Regan wanted to shift from his post as secretary of the Treasury to a place where his formidable appetite for power could be better fed. James A. Baker III, meanwhile, was growing weary after doing a first-rate job as chief of staff. A job swap was arranged and presented as a *fait accompli* to Reagan, who shrugged and said OK.

What the Tower Commission called the "chaos" resulting from the Iran arms scandal has many causes. Regan's administrative ineptitude is high among them. Howard Baker must now seek to impose orderliness and direction on policy-making during the final 23 months of the Reagan presidency. He, too, will need all the help that he can get—not least from a President who faces the considerable challenge of proving anew that he knows how to lead.

Through the Holes in 'Star Wars'

Even a 'Successful' Defense Won't Prevent the Worst

America's "Star Wars" strategic defense system is being designed to stop a Soviet attack by intercepting missiles and warheads in space, where they can supposedly do no harm. In the simulations shown on television, a laser beam or a "kinetic kill" vehicle slams into the attacking missile, which then vanishes in a harmless puff of smoke and flame.

Reality is apt to be much different.

Assume that the worst—and best—happens. Deterrence fails; the Soviets launch, and the American strategic defense system works essentially as imagined. What comes next is not in the TV animator's script. Some attacking warheads are destroyed or disabled above Earth's atmosphere, but most are not; some are simply bumped off-course as they continue their trajectory back down to Earth.

The vehicles that carry the weapons on ballistic missiles and protect them against the stresses associated with their trip back through the atmosphere from space are among the most rugged devices ever built. They must shield against temperatures almost as high as those on the surface of the sun, and be able to take sustained forces of more than 10 times that of gravity. Even the explosion of the booster carrying such re-entry vehicles will not destroy them. The crew compartment of the space shuttle Challenger was far weaker, and yet it survived the fireball essentially intact.

The warheads carried by a Soviet missile destroyed in flight will continue on, following their original trajectories or taking an errant course. The warheads on intercontinental missiles shot down relatively early in their boost phase will not be moving very rapidly, and probably will land in the Soviet Union.

The more time an offensive rocket has to accelerate, the faster its weapons will be traveling if and when the rocket is blown up by a defensive missile. Its warheads will continue in flight for thousands of miles. They might reach the continental United States—or fall just a few miles short or off-target in the ocean, or on Mexico or Canada.

Warheads that successfully re-enter the atmosphere will almost certainly explode, regardless of whether they hit the targets that their makers intended or whether they are far off-course, headed for a Canadian village or an empty cornfield. This possibility makes moot the debate about targeting

or defending military installations instead of civilian populations.

Nuclear missiles intercepted in mid-course high above the atmosphere while on ballistic trajectories toward their targets might explode when hit, or might not. An attacker, hoping to interfere with a defender's weapons and strategy, might equip his warheads with "salvage fuzes." A salvage fuze is nothing but a simple sensor that tells the warhead, "We're hit—blow up while you've got a chance!" Salvage fuzes have an edge of several milliseconds to trigger the nuclear weapon before the defending missile can shatter it into impotent pieces.

It would, of course, be best if Soviet warheads exploded high in space, rather than at their targets, but nuclear explosions in space are not without consequences. The electromagnetic pulse from even a single weapon can knock out the electric power grid of half a continent; we cannot even speculate on the immensity of the damage to electrical and electronic systems that dozens or hundreds of near-simultaneous bursts would inflict. In any event, the first few explosions might well cripple the rest of the U.S. defense system and allow the rest of the Soviet attack to get through.

Even if the warheads are intercepted and disabled, the toxic radioactive plutonium that they carry will not vanish. If the weapons burn up on re-entry, the plutonium will burn with them and spread throughout the atmosphere. That radiation, however, will be small in comparison to the fallout from weapons that do explode.

If the warheads reach the ground intact, but without exploding, the plutonium may escape and contaminate an area of up to a few square miles, causing local hot spots. The Soviet arsenal of close to 10,000

strategic nuclear warheads probably contains close to 50 tons of plutonium, much of which would be widely dispersed even if U.S. interception efforts turned out to be 100% successful.

Of course, a defended United States would suffer less damage in a nuclear war than if it had no strategic defenses. However, we only would be spared immediate damage, probably at the expense of non-belligerent neighbors. In reality, the end of



the cartoon simulation is the beginning of what will be a disaster of incredible magnitude, respecting no boundaries anywhere.

Since strategic defenses, either Soviet or American, may diminish crisis stability, on balance they probably can be viewed as more likely to cause than to avert nuclear disaster—even if they work.



BILL QURAIISHI TO REPLACE TOM LANTOS

In a totally different arena of active life, Bill Quraishi of El Granada has taken on a major challenge by throwing his hat in the political ring in competition with incumbent Congressman Tom Lantos. Confident...committed...dynamic...even though he has never held any political office or been involved in any political candidacy before, Bill Quraishi is convinced that he has an excellent chance of winning and that he is eminently qualified to do a good job as the Republican representative for this 11th Congressional District.

Bill Quraishi realizes he must raise at least a million dollars to conduct his campaign and he's already had brochures and contribution-cards printed, been in touch with the Republican National Committee, secured good wishes from a number of incumbent senators and congressmen, and plans to attend some workshops for candidates in Washington D.C. He has also persuaded Bob Senz, the popular owner of the Ocean Shore Company (hardware and homeware) to head his steering committee, and that step alone says a good deal for Quraishi.

His basic policies are those of free enterprise and entrepreneurial encouragement, his mentors are Thomas Jefferson and Abraham Lincoln. And if that sounds almost naive in this sophisticated decade, don't dismiss him lightly.

He conveys an intense sincerity, and perhaps a look at the 49 years of his life to date gives us some clues.

Born and raised in Peshawar, Pakistan, he grew up in a multi-lingual society, not only because his mother spoke Russian and his father Arabic, but Peshawar was a free trade zone near the Afghan border. He grew up hearing Urdu (the Pakistani language), Persian, English and a wide range of tongues, ultimately learning to speak Urdu, English, Arabic and German. That language facility stood him in good stead during his later engineering career in various parts of the world.

At the age of ten he knew he wanted to be an engineer, in part perhaps, because an uncle was an engineer, but also because he was good in both math and science and indeed went on to become top student in middle school, high school and college. He won his degree in electrical engineering at the University of Peshawar, then went on to begin his career with a job in Lahore. He had always been impressed, however, with the advanced accomplishments of American and European engineers, and was particularly taken with his concept of the United States as "a land of promise, of free enterprise", attributes that he still considers our greatest assets.

In 1963 he went to West Germany where he spent the next four years. the first two with a

German firm, the last two as an electrical engineer with the U.S. Army, Europe, Engineer Command. In 1967 he came to the United States. It was, he says, "A dream coming true...in steps...you work for it!" His sister had been an exchange student at Colorado State, and he knew people there for that reason, so he headed for Colorado and signed up for some grad study courses at the University of Colorado.



In 1968, he met and married Karen, who was in her final year at Colorado State, working toward her degree in child development. Coastsiders are well acquainted with Karen as the founder of the popular Infant and Toddler Center. They bought a house in Denver, helped by a loan from his boss (by then he was working again as an electrical engineer) and she made the 120-mile roundtrip commute to finish her last year at school.

Bill Quraishi had gone to work for Bechtel Engineering and was transferred to the California Bay area in 1970. They moved to Novato and bought a home there;

daughter Michelle was born in 1971. Bill became Senior Vice President of Fluor Corporation, then joined Westinghouse. It was a four year span that included five transfers back and forth between east and west. They saw a lot of the country, Bill observes.

By 1975 they had had enough of the corporate life with its moving about, and he started his own company, Engineering Management Consultants in Power & Energy, capable of the design, management and construction of million dollar projects. These were jobs under contract to such giants as Bechtel, Pacific Gas & Electric, the U.S. Department of Energy, the Stanford Linear Accelerator project, the city and county of San Francisco. It meant a lot of additional junketing overseas, including a stint as advisor to the Government of South Korea on nuclear power.

Meanwhile the Quraishi family acquired two more members Michelle is now thirteen and accumulating honors in her school career, Kevin is eleven and Andrew is eight. They also move from Novato to El Granada. The whole family, says husband an father, is excited and enthusiastic about his latest goal in life.

Why did he decide to enter the political arena? Bill Quraishi was raised during the Gandhi era with its many demonstrations and strikes. He feels his political awareness began at that time. "American people don't trust politicians," he says. "Fifty percent of those registered don't bother to vote so those few control our destiny. There's a lot of self-interest—you scratch my back and I'll scratch yours. I'm running because Congress needs other than attorneys. I want to bring honesty back. I want the future to be bright for my own three children."

He has seen a lot of the rest of the world and feels that he understands the multi-cultures with whom he must deal. He speaks of the protectionist movement going on, the service orientation of countries like Germany and Japan. He plans to take specific stands on national issues during his campaign next year. For now, (in our leap-about conversation) he approves oil drilling off the coast "if it's out of sight", thinks abortion must be the woman's decision, is devout himself (in religious matters) and believes we must respect others' religious beliefs. We must negotiate from a position of strength, but not with "my 'ism' is better than your 'ism'—I don't believe in that. It's a beautiful world—why can't we do it collectively?"

He recognizes that his candidacy faces enormous obstacles and that there's a lot of work to be done, but he's prepared to conquer those. "I'm a very determined person, I work twenty-four hours a day." He does take time to share family life, to walk, do some jogging and tennis, and he reads a lot to keep up-to-date on political matters. He has taken Karen and the kids back to visit Pakistan several times but makes it very clear that this is now his country and theirs.

A few more samples of this new candidate on the scene: "Government should leave many matters to private contractors. There is so much waste due to complex procurement procedures!" He would eliminate a good part of Civil Service to turn it back to private entrepreneurs. "There should be bare bones government. Local government should be self-sufficient, federal government should stay out of it!"

Bill Quraishi is a gutsy guy. It will be interesting to see how he fares against a very well entrenched incumbent. If you see things as he does you may want to lend him a hand and/or dollars. As a newcomer on the political scene, he'll need every bit of help he can get.

When a political novice feels so strongly about the issues he endorses that he takes on a well entrenched and politically astute incumbent... not just on a local level but for a seat in the Congress of the United States, you have to applaud his courage, determination and enterprise. And Bill Quraishi of Half Moon Bay has a great deal of all three qualities. He's campaigning for Tom Lantos' seat in the House.

It is interesting to note that both came to America from far-away former homes, Congressman Lantos from Hungary, the would-be Congressman Quraishi from Pakistan. Both can claim international background experience; Bill's includes four years in West Germany as an electrical engineer, two of those with the U.S. Army, followed by years of time spent

in other parts of Europe and Asia, particularly since the formation of his own engineering management consulting company in 1975. One job stint was as an advisor on nuclear power to the government of Korea. He feels that this experience has given him a real understanding of the multi-cultures with which the U.S. must interact.

Quoting from an article I wrote about Bill in August of 1985, "His basic policies are those of free enterprise and entrepreneurship, his mentors are Thomas Jefferson and Abraham Lincoln." He is concerned that during his year and a half of campaigning he has found that "50 percent of the people in this country are not interested in how the government is run... of the 50 percent who are interested, only half of them care to vote, so one American out of four tells us what to do." This, he says, is what has made us "a democracy by minority special interests, which is dangerous".

Again stressing "the spirit of entrepreneurship and free enterprise", he would like to see the federal government leave many matters to private contractors because "there is so much waste due to complex procurement procedures". He believes in "bare bones government... local government should be self sufficient; federal government should stay out of the picture."

And, if elected, he would oppose any effort to increase tax rates from the 15/28/34 percent rate provided in the Tax Reform Act of 1986.

Although Bill Quraishi has not personally been active in local community action, wife Karen is very well known and well thought of for her founding and management of the Coastside Infant and Toddler Center.
