



A top-flight chief of staff

President Reagan's selection of Howard Baker as his new White House chief of staff works at two levels.

At the level of immediate need, the move gets Donald Regan out of the Oval Office and away from the president's ear. As the Tower commission report makes all too obvious, Mr. Regan bears a significant portion of responsibility for the Iran-contra debacle. His continued presence in a vital White House role — and Mr. Reagan's continued refusal to cut him loose — has served only to prolong, nearly to the breaking point, a national agony.

At a more far-reaching level, the choice of Mr. Baker installs in the White House — at long last — a chief of staff wise to the ways of Congress and well-respected by Republicans and Democrats.

From 1981 through his retirement from the Senate in 1984, Mr. Baker distinguished himself as that body's majority leader, just as he had distinguished himself earlier through his work on the Senate Watergate Committee. His long service on the Foreign Relations Committee gives

him a breadth of experience on the international scene that Mr. Regan sorely lacked. He's no stranger, either, to the way budgets are written.

Mr. Baker will have to put his presidential ambitions on hold. For the next two years he will be too busy running the White House to run for it. Still, the exposure stands to boost his stock for any future race, which may help explain why he took the job after former Sen. Paul Laxalt and former Transportation Secretary Drew Lewis reportedly had turned it down.

More to the point, Mr. Baker's appointment is to the nation's benefit. For three months now the White House has been doing a scene straight out of soap opera. Mr. Baker's presence promises to put a lid on the melodrama and get Mr. Reagan redirected toward the critical issues facing his presidency.

The trade deficit, the budgetary crisis, Soviet relations — these matters won't resolve themselves. Whether Mr. Reagan has the right answers is one matter. That he must begin once again to show leadership is beyond dispute.

Seminole the vital link

Gentlemen, start your engines.

Florida Reps. Frank Stone and Rich Crotty are revving up an effort that could lead to a much-needed Central Florida expressway authority. Hallelujah.

Granted, a better expressway system is only one aspect of fixing the roads in the Orlando area this year. An increase in the gasoline tax is needed as well if Orange, Seminole and Osceola counties are to address the roads that cannot have tolls. But a regional expressway authority can solve the problem of how to build a beltway around the Orlando area.

With such an authority, all of the area's

a regional authority. That is why Seminole County Commissioner Barbara Christensen loves the idea.

Problem is that others from the Seminole County Commission are hesitant. Chairman Fred Streetman says he is not convinced a regional expressway authority could do a better job than could Seminole County on its own.

But look at the bonding power that a united authority would create — particularly if money generated from Florida's Turnpike tolls could be used to help build the beltway. A united authority clearly could do a better job.


