
I wish to offer my sincerest congratulations and best wishes on your appointment. Further, I wish to reiterate my continuing support and commitment to you in your future endeavors.

A run from the Rose Garden?

Howard Baker was in Florida deciding whether to run for president when Ronald Reagan asked him to be White House chief of staff. Baker said yes to the President, and in doing so said no to his own presidential bid.

"I will not be a candidate for president in 1988," he told us.

That made sense. Nobody—not even someone of Baker's talent and experience—could serve as chief of staff and do battle in a series of presidential primaries. It's impossible to be both the President's right-hand man and a candidate for his job. Right?

Wrong.

Being chief of staff might be a blessing in disguise for a "Baker in '88" campaign. Conventional wisdom, which says that Baker cannot campaign actively in next year's presidential primaries, overlooks an important point: Not being able to campaign may actually work to his advantage.

Incumbent presidents have often used pressing White House business as an excuse for avoiding campaign rituals like kissing babies, shaking hands and debating opponents. It's called a Rose Garden strategy, after the famous White House flower bed. It worked for Jimmy Carter in the Democratic primaries of 1980, and it could work again for Howard Baker in 1988.

Baker can say he's too busy running the White House to run for the White House. That will not, however, prevent his supporters from placing his name on primary ballots, organizing voters in key states and raising millions of dollars to support the operation. Put simply, a Baker campaign could mark the first time in history a non-president has used a Rose Garden strategy in his race for the Oval Office.

For the next two years, the former Tennessee senator will have all the political advantages of a sitting president. He will be at the hub of the news. He will have the chance to display decisive leadership in a way a mere candidate could not. He also will be able to set the nation's political agenda, perhaps even determining the central issues of the '88 campaign—all this while being on the ballot but remaining in the Rose Garden.

While Bob Dole is in Iowa debating farm price supports, Baker could be in the Senate pushing through legislation to help trim the budget deficit.

While Jack Kemp is fighting for a 10-second "news

bite" on New Hampshire television, Baker could be chatting with ABC's Sam Donaldson about the Baker—oops, Reagan—administration's new U.S.-Soviet arms control package.

And while Al Haig conducts his own version of Sherman's March, impressing Southern primary voters with his command of foreign policy, Baker could be marching as well: to England to talk with Margaret Thatcher, to China to meet with Deng Xiaoping and to Israel to confer with Yitzhak Shamir.

In a brilliant display of "political jujitsu," Baker can turn what is apparently his greatest weakness—not being able to campaign actively—into his greatest strength. By subtly presenting himself as the de facto

national leader, Baker can run as an incumbent even though he does not now hold national elective office.

Critics who might dismiss this theory as implausible should consider the following:

Reagan is the most remote, disengaged president in recent history. His key aides have always wielded incredible power. Baker, one of the few respected people left in the White House, will have free reign and extraordinary control over policy.

Moreover, Baker is too savvy to overlook the political advantages of this situation. Indeed, it might be one reason he got into it in the first place. Baker ran for president in 1980 and was ready to run again in 1988. He's too much a politician to abandon this life-long dream.

Political fortunes change quickly. Six months ago, Reagan was riding high. Now, after the Reykjavik disaster, the loss of the Republican Senate and the Iran-contra scandal, his presidency is in disrepair. Six months from now, Howard Baker could be the most respected figure in politics.

The first primaries are not for another year, which in politics is an eternity. During that time, a dozen Republican contenders will be criss-crossing the nation in search of dollars and delegates. However, when the media turn their eyes to Iowa and New Hampshire for the next Republican nominee, they could be making a mistake. The guy they should be watching might already be in the White House.

I don't know how to address you. Which is proper?



The obvious solution is to let Howard Baker govern while Reagan plays the role of President. If he will only do it.




