MARINA v.N. WHITMAN

Marina v.N. Whitman was elected Vice President and Chief Economist of General Motors by the Board of Directors effective August 1, 1979. A summa cum laude graduate in government from Radcliffe College, with a master's degree and doctorate in economics from Columbia University, she is headquartered in New York City where she directs the operation of the company's economics staff in both New York and Detroit.

Prior to joining GM, Dr. Whitman was Distinguished Public Service Professor of Economics at the University of Pittsburgh. She previously served as a senior staff economist with the Council of Economic Advisers (1970 - 1971), as a member of the U.S. Price Commission (1971 - 1972), and was chosen by President Nixon as one of three members of the President's Council of Economic Advisers (1972 - 1973).

Throughout much of her career, Dr. Whitman has been associated with a number of academic, governmental and private advisory organizations concerned with domestic and international economic issues and their interrelationship. Among them are the Council on Foreign Relations (Director), Group of Thirty, the Trilateral Commission, the American Enterprise Institute and the Brookings Panel on Economic Activity; a member of the Advisory Committee on the International Monetary System of the U.S. Treasury Department, the President's Commission on Executive Exchange and the Advisory Board for Issues in Science & Technology published by the National Academy of Sciences. She is a member of the Board of Directors of the Manufacturer's Hanover Trust Company and the Procter and Gamble Company, a member of the Board of Trustees of Princeton University, and was formerly a member of the Board of Overseers of Harvard University.

versities and has received a number of fellowships or awards, including Columbia University's 1973 Medal for Excellence and Columbia's 198- Award for Excellence. Upon graduation from Radcliffe in 1956, she received the Phi Beta Kappa Prize for the highest ranking senior. During the 1978-79 academic year Dr. Whitman was on sabbatical leave as a Fellow at the Center for Advanced Study in the Behavioral Sciences at Stamford, California.

Dr. Whitman was born in New York City on March 6, 1935. Her father was the late mathematician John von Neumann. She is married to Dr. Robert F. Whitman, Professor of English at the University of Pittsburgh, and they are the parents of two children.

She began her teaching career in 1962 as a lecturer in economics at the University of Pittsburgh, was advanced to associate professor in 1966 and attained full professorship in 1971.

Dr. Whitman has contributed frequently to the economics literature. In her most recent book - Reflections on Interdependence, published in 1979 by the University of Pittsburgh Press - she explores the impact on economic analysis and on U.S. foreign economic policy generated by the growing mutual dependency of nations since the end of World War II. Her 1981 monograph, International Trade and Investment: Two Perspectives, published by Princeton University's International Finance Section, relates actual patterns of international production, trade and investment in the automobile industry to the patterns that would be predicted on the basis of economic theory. She has also conducted a weekly television program, "Economically Speaking", that was carried by 180 Public Broadcasting Service Stations.
