SUBJECT:

Senator Pepper's request concerning
Visit of Mr. Voss

The NSC staff followed-up on your conversation with Senator Pepper. They informed Senator Pepper that no White House reception would be held for Mr. Voss because he had been head of the Latvian Communist Party. Such a reception would infuriate American Latvians in this country.

An attempt was made to arrange a White House VIP tour for Mr. Voss, but we were unable to arrange a tour since the only day that Mr. Voss was available tours were not given due to the Mubarak visit.

Ambassador Kampelman indicated that he was willing to meet with Mr. Voss and Mr. Voss was supposed to come with the Soviet Politbureau Delegation but he did not attend the meeting.
