SUBJECT: Request for Presidential Meeting

We strongly advise against the President meeting Ryoichi Sasakawa. Sasakawa was incarcerated after World War II as a Class A war criminal, but never brought to trial. In recent years, he has engaged in public philanthropy, using vast amounts of money from the Japan Motorboat Racing Association (Japan's biggest legal gambling activity) and other organizations Sasakawa heads. Although philanthropy has given Sasakawa association with respectable individuals, including former President Carter, Sasakawa's reputation in Japan is very poor, with reports of continuing links to organized crime.

Sasakawa's driving ambition in his remaining years (he is perhaps in his 90's) is to win the Nobel Peace Prize. A meeting with the President would serve that end. It would not, however, serve the President.

DEAR HOWARD:

THANK YOU VERY MUCH FOR YOUR WARM LETTER. I AM DELIGHTED TO BE BACK IN TOKYO AND AM FEELING GREAT. WITH RESPECT TO YOUR REQUEST FOR MY VIEWS ON THE POSSIBILITY OF THE PRESIDENT RECEIVING RYUICHI SASAKAWA, I MUST EXPRESS MY STRONG RESERVATIONS. MR. SASAKAWA HAS GIVEN LARGE SUMS OF MONEY TO CHARITABLE CAUSES IN RECENT YEARS, INCLUDING PROVIDING THE INITIAL CAPITAL FOR THE U.S.-JAPAN FOUNDATION, AND HAS BEEN HONORED BY MANY FOR THESE CONTRIBUTIONS. IN MY VIEW, HOWEVER, THIS DOES NOT OVERCOME A VERY UNSAVORY PAST OR HIS REPUTED CURRENT TIES WITH THE JAPANESE UNDERWORLD AND EXTREME RIGHT WING GROUPS.

BEFORE THE WAR, SASAKAWA ORGANIZED A FASCIST PARTY THAT WAS RESPONSIBLE FOR POLITICAL ASSASSINATIONS IN THE 1930S. AFTER THE WAR, HE WAS IMPRISONED BY THE US AS A WAR CRIMINAL FOR THREE YEARS ON CHARGES OF ARMS TRAFFICKING. IN THE POST WAR PERIOD, HE HAS BECOME HEAVILY INVOLVED IN MOTOR BOAT GAMBLING AND WITH ARIOUS RIGHTWING CAUSES, INCLUDING REVEREND MOON'S UNIFICATION CHURCH. HE IS WIDELY REGARDED HERE AS AN UNSCRUPULOUS SELF-PROMOTER IN SEARCH OF THE NOBEL PEACE PRIZE.

IN SHORT, FOR ALL HIS RECENT "GOOD WORKS," SASAKAWA IS NOT THE KIND OF PERSON WITH WHOM THE PRESIDENT SHOULD BE ASSOCIATED.



Dear Glenn:

As I told you I would, I did a little background checking on Ryoichi Sasakawa and got a very negative report. Mike Mansfield reports that while Sasakawa has given large sums of money to charitable causes in recent years, that in Mike's view this still does not overcome a very unsavory past or his reputed current ties with the Japanese underworld and extreme right wing groups. It is also reported that Sasakawa organized a fascist party that was responsible for political assassinations in the 1930's. In the postwar period he has become heavily involved in motorboat gambling and connections, in some way, with Reverend Moon's Unification Church.

State also advises against the meeting, therefore, we think it is wise to drop it.
