I share your concern over the current status of the foreign affairs account. Both the House and Senate have assumed dangerously low levels for next year's budget. I met recently with Secretaries Shultz and Baker to discuss a way out of this perilous situation. While we may be able to get some relief in the Senate, I fear the outcome of a budget conference. And, as you know, it is almost impossible to raise the spending level for foreign assistance through use of a veto.

The simplistic but necessary solution is to find a majority in both houses willing to vote for foreign aid -- a difficult task in the best of times, but doubly so with the menace of a huge budget deficit. I cannot tell you that I am optimistic about the prospects at the moment, but I can assure you that we are fully aware of the problem and doing all we can to address it.
