Thank you for inviting me to meet with Dr. Henry Kendall, the Chairman of the Board of Directors of the Union of Concerned Scientists.

Regrettably, due to the heavy demands of my schedule, I am unable to accept your kind invitation. Let me assure you, however, that the deep concern and interest which prompted you to write are appreciated. As the enclosed recent statements of President Reagan make clear, he is determined to pursue negotiations with the Soviet Union designed to achieve deep, equitable, and verifiable reductions in nuclear arsenals and to increase global stability. At the same time, he is certain that the Strategic Defense Initiative not only truly serves the purposes of offensive weapons reductions, but that it can help move us to a safer world, reducing the danger of accidental warfare and providing an insurance policy against violations of a future arms reductions treaty.

May I suggest that Dr. Kendall and other representatives of the Union of Concerned Scientists may wish to discuss these and related issues in some detail with appropriate officials of the Arms Control and Disarmament Agency, such as Director Kenneth Adelman.
