Thank you for your July 2 letter in which you encourage the Administration to back away from the 1984 Mexico City policy on abortion and family planning.

As you know, the policy of this Administration is to provide strong support for voluntary population programs, but firm opposition to abortion as a method of family planning. To implement this policy, the Agency for International Development (AID) does not provide U.S. funds to foreign nongovernmental organizations that perform or actively promote abortion as a method of family planning. This policy does not infringe on the rights of foreign organizations to decide how they will spend their own funds, nor on the opportunity Third World women have to obtain advice from whomever they wish regarding their pregnancies. Rather, the United States has the right to decide how it will spend its funds for population assistance.

The Administration is firmly committed to the Mexico City policy. It is important to note, however, that implementation of the Administration's policy (i.e., AID's withholding funds from foreign organizations which engage in abortion activities) has not reduced total U.S. family planning assistance. AID has increased its support for family planning under this Administration, and AID remains the largest single donor in international family planning, providing more than 40 percent of the estimated \$500 million in assistance from all international donors last year.

Dear Mr. Hartquist:

Thank you for your recent letter regarding the specialty steel Section 201 import relief program. I also appreciate your sending me a copy of the June 12 letter to the President signed by Lynn Williams and Richard Simmons.

As you know, on July 16, the President signed a proclamation extending existing import relief for the specialty steel industry until September 30, 1989, when the remainder of his national steel program expires. The objective of that program is to bring an end to constant trade disputes over steel by reversing global trends toward excess capacity, greater subsidization and increasingly protected foreign markets. Moreover, the relief was granted in the form most consistent with the President's belief that government should interfere with the market place as little as possible and that when government action is necessary, it should facilitate orderly adjustment in the industry.

Thank you for bringing the views of the specialty steel industry of the United States and the United Steel Workers of America to my attention.
