Henry Nau is currently a professor of Political Science and International Affairs at the Elliott School of International Affairs at George Washington University. He holds a B.S. degree in economics from the Massachusetts Institute of Technology, and M.A. and Ph.D. degrees in International Relations from the Johns Hopkins University. He is also the current director of the U.S.- Japan Legislative Economic Agenda and the U.S. Japan Legislative Exchange Program.

Prior to his work with the NSC, Professor Nau served in the Department of State as an Under Secretary for Economic Affairs (1975-1975), as a Special Assistant, Under Secretary for Economic Affairs (1976-1977), and as an expert in the Foreign Affairs Office (1977-1981).

Professor Nau served as a senior staff member with National Security Council from February 1981-July 1983 He worked in the International Economic Affairs Directorate. One of his primary duties at the NSC was coordinating policy for the G-7 Economic Summits.
