### **SPRINKEL, BERYL W.: Files, 1985-1989 (39 feet)**

Council of Economic Advisers: Chairman

#### **Biography**

Beryl W. Sprinkel was the Department of Treasury Undersecretary for Monetary Affairs from 1981-1984. President Reagan nominated him as the Chairman of Economic Advisers in the Executive Office of the President. He was confirmed by the Senate in June 1985 and remained until the end of the Reagan administration.

Mr. Sprinkel was known as a monetarist, a branch of economists who believe that money supply — and only the money supply — determines the rate of economic growth and inflation. In books like “Money and Stock Prices,” Mr. Sprinkel strove to explain the implications of this economic philosophy.

Beryl Wayne Sprinkel was born into a farm family in Richmond, Missouri, on November 20, 1923. He served in the Army as a tank gunner in World War II; he then earned a degree in economics from the University of Missouri. He studied at the University of Chicago, where he earned an M.B.A. and a Ph.D., and immersed himself in the monetarist ideas of Nobel-prize winning economist, Milton Friedman.

Sprinkel worked at the Harris Trust and Savings Bank of Chicago from 1952 to 1981, rising to executive vice president. Then Donald T. Regan, Mr. Reagan’s choice to be secretary of the Treasury, chose Mr. Sprinkel to be his undersecretary for monetary affairs. Mr. Regan said he wanted “the best monetarist I can get.”

Mr. Sprinkel gained a reputation for outspokenness, criticizing the Federal Reserve and foreign economic officials, as well as apostles of supply-side economists who thought tax cuts were the answer to every economic question. He took a tough line on loans to debtor nations, even ones in crisis.

In February 1985, Mr. Sprinkel was nominated as chairman of the Council of Economic Advisers, a job that Reagan had considered abolishing. Mr. Sprinkel played down his new role, saying Mr. Reagan had an “amazing” knowledge of economics and was “his own chief economic adviser.”

Sprinkel oversaw the booming economic times of the second Reagan administration. His advice and influence with the President helped to move the economy past the collapse of the stock market on Monday, October 19, 1987. Sprinkel had been warning for some time about the possibility of a stock market crisis. When it occurred he persuaded Reagan to agree to negotiate with Congress on higher taxes and to keep all markets open. These actions were perceived by Wall Street as positive moves regarding the economy and the situation calmed and eventually reversed the crisis by the end of the Reagan administration.

Sprinkel died at the age of 85 on August 22, 2009.

### **Scope Note**

While nominated in February 1985, Sprinkel was “acting Chairman” until his confirmation in June 1985. His collection contains material dating from that time and has some material he brought with him from the Department of Treasury.
