SUBJECT: Reprinting of the President's Abortion Article

Kathleen Bursley, an attorney for Harcourt Brace Jovanovich, Inc., has written to ask for a public domain copy of "Abortion and the Conscience of the Nation," by the President. Harcourt wants to include the article in a college rhetoric text as an example of argumentation. They approached Thomas Nelson, Inc., which published the article in book form, for permission. Thomas Nelson is demanding a fee of \$1,000, which Bursley considers exorbitant under the circumstances.

You will recall that this article first appeared in the Summer 1983 issue of Human Life Review, and was copyrighted at that time by the publisher of Human Life Review, The Human Life Foundation, Inc. The article was later published in book form by Thomas Nelson, pursuant to an arrangement whereby royalties benefit The Human Life Foundation. You approved the Nelson reprint and the royalties arrangement by letters dated November 7, 1983. The article has also been distributed by the White House in pamphlet form, bearing the Seal of the President, with no copyright notation.

As I read the law, no copyright protection is available for the article. There was no basis for the publishers of Human Life Review to copyright it when it first appeared. The article was clearly Government work, and not the private product of the President. It was drafted by OPD and Speechwriters, with editing by Peter Rusthoven of this office, and went through the White House clearance process. There is no copyright protection "for any work of the United States Government." 17 U.S.C. § 105. "Work of the United States Government" is defined to be "a work prepared by an officer or employee of the United States Government as part of that person's official duties." 17 U.S.C. § 101. The article clearly fits that definition from the perspective of those on the White House staff who prepared it. Since it expresses the President's view on a public policy issue, and was designed to shape the debate on that issue, the article should also be considered to have been prepared by the President in the course of his official duties.

The Presidential Records Act confirms this conclusion. The article certainly qualifies as a Presidential record, see 44 U.S.C. § 2201, and ownership, possession, and control of such records is retained by the United States, 44 U.S.C. § 2202.

My recommendation would be to send Harcourt one of the White House pamphlets of the article, advising that no permission is necessary to reprint it. I would alert The Human Life Foundation and Thomas Nelson before doing so, since they are apparently under the impression that they have some rights to the article. I have not called them yet, however, since the fact that the article was copyrighted by the Foundation, and the fact that this office has granted reprint permission (to Thomas Nelson) and denied reprint permission (to Charisma) suggest my view of the law may not have been previously operative in this area. Peter may have discussed these issues with you; perhaps there are some facts (not revealed in the file, which I have reviewed) of which I am unaware. Please advise.

Dear Mr. Fielding:

Ms. Eleanor Garner, of Harcourt Brace Jovanovich's College Department, spoke to someone in your office concerning the above-referenced article, and was asked to put the request in writing and direct it to you.

The situation arose when one of our authors wished to use this article in a rhetoric text as an example of argumentation. He had seen the article in a pamphlet published by Thomas Nelson, Inc., and he therefore requested permission from Thomas Nelson to use it in this way. Thomas Nelson demanded a fee of \$1,000.00 (lowered from the \$2,000.00 fee originally quoted). This fee is at least five times as high as any fee quoted for other permissions material used in this book. We found this particularly troubling since the article was written by a sitting President and was not in any case to be used in a manner competitive with Thomas Nelson's publication.

I then contacted Thomas Nelson to try to determine the basis for the high fee, and to confirm that they were in fact authorized to grant or deny permission in this way. The person I spoke to reiterated the original position.

In the meantime, Ms. Garner attempted to locate a public domain copy of the article, since she had been informed that it had been submitted to a congressional committee holding hearings on a human life bill, and that the transcripts of the hearings had been published by the government printing office. Her efforts to locate this publication at the nearest federal document depository were unsuccessful. Eventually, she was referred to the White House library and then to your office.



SUBJECT: Talking Points Regarding Phone Call
to Americans Against Abortion Rally

David Chew has asked that comments on the above-referenced talking points be sent directly to Linda Chavez by 1:00 p.m. today. The President will use the talking points in a Sunday telephone call to the anti-abortion rally in Los Angeles.

The remarks call for reversing "the tragedy of Roe v. Wade and Doe v. Bolton," but the President has done that often in the past. The rest of the remarks simply express support for the pro-life position, noting advances in medical technology that permit increased care for the unborn, and applauding those who are providing compassionate alternatives to abortion. I have no objections.

SUGGESTED TALKING POINTS FOR MEETING WITH
AMERICANS AGAINST ABORTION RALLY, LOS ANGELES, CALIFORNIA

- I am pleased to have this opportunity to greet everyone attending the Americans Against Abortion Rally. Our talking together coast-to-coast symbolizes one of the great truths about the right to life issue which you've gathered to support -- it's truly among the most important issues facing our nation today and Americans from every corner of this land are working harder than ever before to see that justice is done and the tragedy of Roe v. Wade and Doe v. Bolton is reversed;
- Not long ago, in the dead of winter in our Nation's Capital, I spoke to a similar gathering -- the March for Life in Washington, D.C. The brave people who came to Washington in the ice and cold of January demonstrated the character of the movement to which you belong -- it isn't one for fair-weather friends. While California in June might be a little warmer, the men, women, and children attending this rally show the same basic qualities -- unlike some who plead for special causes, you plead for one in which there isn't a shred of self-interest. You speak for those who

cannot help themselves, who -- until recently -- were for all intents and purposes unseen and unheard. You give them -- the unborn -- a voice and a hope, and as a result of your actions, the conscience of a Nation is being moved;

-- One of the most important ways this is being done is through the "window in the womb" now provided by advances in medical technology. Doctors now speak of the "patient in the womb," a powerful acknowledgement that it is the work of medicine to heal, not to destroy. The unborn can now receive blood transfusions and medication in utero. And, for the first time, through the technique of real-time ultrasound imaging, the evidence of what abortion does to end the life of a living human being is available to anyone who has eyes to see;

-- I've spoken here of the evidence today that establishes that the unborn is a living human being. We must not forget that, in reality, if there is any justice in the abortionist position, it would require that they establish beyond a doubt that there is not life in the unborn -- and they can't do that;

- It's been a long, hard struggle the past dozen years. But I know all of us are feeling hopeful about a positive resolution of this issue, and I don't think our feeling of hope is inappropriate. There are already signs that we've changed the public attitude on abortion. The number performed each year is finally leveling off. The general feeling that abortion is just a small, harmless medical procedure that's simply a matter of choice has almost disappeared;

- We're making a lot of progress, and partly because a dozen years ago people like yourselves, who were told that banning abortion was a losing battle, said, "Fine, that's the only kind of battle worth fighting;"

- Let me also take this opportunity to express my thanks to those present for all you've done to open hearts and homes to women with problem pregnancies. As I've said before, the essence of your work is voluntarism in the truest sense, and your efforts to provide alternatives to abortion are a classic example of a tremendous need being met by awesome generosity. The growth of this aspect of the pro-life movement gives us all cause for optimism about the course of public

debate over the abortion issue. You haven't given into the false dichotomies and conflicts that some would impose on this subject -- you see your responsibility to help and protect both mother and child -- to guard life, to offer solace and hope, to stand with others in need not for a few minutes and a fee but for a lifetime of concern and caring if necessary. God bless you for this inspiring work -- I know that in many ways He already has;

-- I'm proud to be with you on this occasion and to wish you well in our common endeavor to restore the sanctity of innocent life as a guiding principle of our democracy. Thank you for your courage and commitment to this vital cause.

You have asked for my views on a proposed form letter and proposed fact sheet on the Government's filings in Thornburgh v. American College of Obstetricians and Gynecologists and Diamond v. Charles, pending before the U.S. Supreme Court. The form letter and the fact sheet review the facts of the pending cases and the Government's legal arguments.

Consistent with established White House policy, neither the form letter nor the fact sheet may be approved. We adhere to a policy of not commenting from the White House on particular cases pending before the courts. Inquiries concerning such cases should be referred to the Department of Justice for appropriate handling. There is the danger that comment from the White House on a matter pending before the courts could prejudice the consideration of the case, to the detriment of the Government's position. In addition, White House involvement raises concerns about the intrusion of political considerations into the formulation of the Government's legal position by the Department of Justice, again to the detriment of the Government's position. Particularly in such a sensitive area as this, every safeguard should be observed to ensure that the Government's arguments before the Court are perceived as legal, not political.

SUBJECT: Presidential Message for Aborted Fetuses

On October 3, 1985, Charles Donovan, for Anne Higgins, provided my office with a copy of a proposed Presidential message to be sent to the October 6 memorial service for the aborted fetuses discovered in Los Angeles in 1982, for our review. On October 4, my office telephoned Donovan and advised him that the message should not be sent. This decision was based upon my review of the legal dispute surrounding the burial, and the egregious misuse of a previous Presidential message by the same individual requesting this one.

According to this morning's edition of the New York Times, however, the very message I had explicitly disapproved was in fact sent. I would like an explanation of why the system of review we have in place failed to function in this instance.

SUBJECT: California Pro Life Medical Association Event, October 6

Charles Donovan, for Anne Higgins, has asked for our review of a proposed Presidential telegram to be sent to a memorial service to be held in Los Angeles on October 6 for the 16,500 aborted fetuses discovered at a medical laboratory in 1982. You will recall that local government officials originally planned to turn the fetuses over to a private group for a religious burial, but the plan was blocked by the ACLU and the Feminist Women's Health Center. The state courts directed the officials to dispose of the remains by cremation or burial, without arranging or participating in religious ceremonies. The officials now plan a non-religious burial, and the California Pro Life Medical Association (CPLMA) is planning a separate memorial service. CPLMA has been actively involved in the issue since the beginning.

Donovan notes that sending a message would be an appropriate follow-up to the President's May 5, 1982, letter to Dr. Phillip Dreisbach, Secretary for CPLMA (Tab A). That letter, prepared and sent by Higgins without our knowledge (according to Peter Rusthoven's files), praised CPLMA's decision to hold a memorial service for the fetuses. Dr. Dreisbach later sent a photo exhibit to the President, featuring the May 5 letter surrounded by pictures of aborted fetuses. Mr. Hauser sent a letter to Dr. Dreisbach, protesting the planned use of the President's letter (Tab B).

I have only one small objection to the text of the proposed telegram. In the third paragraph, the text states that the Roe and Doe decisions "made void all our laws protecting the lives of infants developing in their mothers' wombs." This is legally inaccurate, since Roe v. Wade permitted some regulation of abortion -- and even a ban on abortion -- depending on the stage of the pregnancy. I would change "all our laws" to "many of our laws." With this change, I have no objection to the text. It criticizes the Roe and Doe decisions, to be sure, and states that they cannot long endure, but the President has said as much often in the past.

Nor do I have any objection to the President sending a message to the memorial service. The President's position is that the fetuses were human beings, or at least cannot be proven not to have been, and accordingly a memorial service would seem an entirely appropriate means of calling attention to the abortion tragedy.

My concern is sending another message to Dreisbach, who was prepared to misuse the previous Presidential message on a gruesome anti-abortion display. I recommend approving the telegram (with the one change), but making certain the recipients understand that it may not be reprinted or used in any future materials. A memorandum for Donovan is attached.

Dear Dr. Dreisbach:

This will acknowledge and respond to your recent letter to the President enclosing a copy of the anti-abortion photographic exhibit your organization wishes to display in Washington, D.C., and requesting an opportunity to show the exhibit to the President.

The President will be unable to accommodate this request for a personal meeting. In addition, we must protest the reproduction on this exhibit of the President's letter of May 5, 1982 and ask that your Association cease to use any reproduction of that letter either on this poster or in any of your literature.

As you know, the White House did not grant permission for this use of the President's letter. More generally, Presidential messages of this sort are not intended to be reproduced by their recipients for recruiting, promotional or fundraising or other extraneous purposes. Finally, as you were advised by Peter Rusthoven of our staff in his letter of August 13, 1984, the President, despite his frequently articulated personal opposition to abortion, cannot comment on matters pending before State courts -- something which the inclusion of this 1982 letter in your photographic exhibit suggests he is doing.

I will appreciate your prompt written assurance of intent to comply with the requests set forth above, and trust you can understand the reasons for those requests.

I have received your letter and I want you to know of the great horror and sadness evoked by the incident you described. When all is said and done, being confronted with the reality of abortion and its consequences removes all trace of doubt and hesitation. The terrible irony about this sudden discovery is not that so many human lives were legally aborted, but that they are only a tiny proportion of the 1.5 million unborn children quietly destroyed in our nation each year. This is the truth many would rather not face.

Your decision to hold a memorial service for these children is most fitting and proper. On such an occasion, we must strengthen our resolve to end this national tragedy. I am hopeful that evidence like that found in California will move those who have thus far preferred silence or inaction and encourage them to agree that something must be done. I have expressed my anticipation that Congress act expeditiously on this matter and approve a measure which will remove this evil, and all its vestiges, from our society.

On May 5, 1982, your office prepared and sent a letter from the President to Dr. Dreisbach, stating that a decision to hold a memorial service was "most fitting and proper." (The message was neither submitted to nor approved by this office.) Dr. Dreisbach subsequently misused the May 5 letter by reprinting it on a photo display featuring pictures of aborted fetuses. This office was compelled to write Dr. Dreisbach on January 28, 1985, protesting his misuse of the President's message.

While I have no legal objection to sending a message to the memorial service, I am quite concerned about another possible incident of misuse by Dr. Dreisbach. Accordingly, in sending the message, you should warn Dr. Dreisbach that while it may be read at the memorial service it may not be reprinted or otherwise used by him in any future materials. If Dr. Dreisbach is not fully agreeable to these conditions, no message should be sent.

With respect to the proposed text, "all" in line 12 should be changed to "many of." Roe and Doe did not void all laws regulating abortion, and in fact recognized the validity of certain regulations and even prohibitions, depending on the stage of the pregnancy.

The President's position is that the fetuses were human beings, or at least cannot be proven not to have been, and accordingly a memorial service would seem an entirely appropriate means of calling attention to the abortion tragedy.

Dear Dr. Dreisbach:

This will acknowledge and respond to your recent letter to the President enclosing a copy of the anti-abortion photographic exhibit your organization wishes to display in Washington, D.C., and requesting an opportunity to show the exhibit to the President.

The President will be unable to accommodate this request for a personal meeting. In addition, we must protest the reproduction on this exhibit of the President's letter of May 5, 1982 and ask that your Association cease to use any reproduction of that letter either on this poster or in any of your literature.

As you know, the White House did not grant permission for this use of the President's letter. More generally, Presidential messages of this sort are not intended to be reproduced by their recipients for recruiting, promotional or fundraising or other extraneous purposes. Finally, as you were advised by Peter Rusthoven of our staff in his letter of August 13, 1984, the President, despite his frequently articulated personal opposition to abortion, cannot comment on matters pending before State courts -- something which the inclusion of this 1982 letter in your photographic exhibit suggests he is doing.

I will appreciate your prompt written assurance of intent to comply with the requests set forth above, and trust you can understand the reasons for those requests.

Dear Mr. Mazzoli:

Thank you for your letter of January 29 to the President. In that letter you expressed concern over reports about a conversation between the President and Pro-Life leaders on the possibility of pardons for those convicted in connection with bombings of abortion clinics.

The President unequivocally condemns such acts of violence and believes that those responsible should be prosecuted to the full extent of the law. No matter how lofty or sincerely held the goal, those who resort to violence to achieve it are criminals.

The President has no intention of granting special treatment in the pardon process to those convicted of violence against abortion clinics. Any requests for pardons received from such individuals will be processed in the first instance by the Pardon Attorney in the Department of Justice, as is true of pardon requests in general. The resolution of any pardon request cannot be determined in advance of receipt of the particular request, since a decision to grant or deny a pardon depends upon careful review of all the facts of a specific case. I can assure you, however, that in considering any pardon requests from those convicted of violence against abortion clinics, neither the cause that these misguided individuals mistakenly believed they were serving, nor the target of their violence, will in any way be considered to mitigate the seriousness of their offense against our laws.

I hope the foregoing responds to your concerns. Thank you for sharing your views on this matter with us.
