On February 15, 1985 Paul J. Coleman, Jr., telephoned to discuss the possibility of his continuing to be employed as a consultant to Boeing Aircraft Company during his service on the National Commission on Space. Mr. Coleman had listed the Boeing consultancy on his previously submitted Personal Data Statement, but had not indicated that he wished to continue it during his government service. He stated that he would be willing to discontinue the consultancy if necessary or appropriate.

I advised Mr. Coleman that he could continue his arrangement with Boeing, in light of the broad nature of the Commission's work. This advice was consistent with that given other Commission members, as memorialized in my clearance memorandum on appointees to this Commission. I further advised Mr. Coleman that he should be alert to recuse himself from particular discussions if they should ever concern a particular matter with a directly discernible effect on Boeing, and that he should not hesitate to seek further advice if he has any other conflicts questions as the work of the Commission proceeds.

I have reviewed the Personal Data Statements submitted by the above-named individuals in connection with their prospective appointments to the Advisory Committee for Trade Negotiations. The president is authorized to appoint 45 individuals to this committee, including "representatives of government, labor, industry, agriculture, small business, service industries, retailers, consumer interests, and the general public." 19 U.S.C. § 2155(b)(1).

Mr. Tripp is an attorney and chairman of a private investment company; Mrs. Wachner is director of consumer products for Adler & Shaykin; Mrs. Weinman is President of a Silicon Valley firm; Mr. Danzansky heads the Washington office of the law firm Willkie Farr & Gallagher. No problem is presented by any of the Personal Data Statements. All of the prospective appointees have interests in the trade area. These are not disqualifying, however, in light of the general policy role of the committee and the fact that the statute specifically directs that the various groups affected by trade policy decisions be represented on the committee.

Mr. Danzansky was registered as a foreign agent, the registration terminating in August 1984. I took the precaution of telephoning him and alerting him to the prohibition in 18 U.S.C. § 219, should he ever need to register in the future.

On February 28, 1985, I telephoned Ralph Tarr, Acting Assistant Attorney General for the Office of Legal Counsel, to obtain his advice concerning the prospective appointment of Maureen Reagan to the U.S. Delegation to the World Conference of the United Nations Decade for Women, 1985. My question to Tarr was whether any problems were presented under the Anti-Nepotism Act, 5 U.S.C. § 3110, by Maureen Reagan's appointment. Tarr researched the question and returned my call later in the day.

The President is authorized by 22 U.S.C. § 287(d) to appoint individuals "to represent the United States in organs and agencies of the United Nations." That authority, with respect to organizations such as this Conference, was delegated to the Secretary of State on February 28, 1948, by President Truman. Tarr advised that in light of the delegation of authority Maureen Reagan's appointment would not constitute a violation of the Anti-Nepotism Act. According to Tarr, the statute is concerned with the act of appointment, and a delegation of authority operates to transfer responsibility for that act to the delegate.

I have reviewed the Personal Data Statement submitted by Gerard K. O'Neill in connection with his prospective appointment to the National Commission on Space. The Commission was established by Public Law 98-361, 42 U.S.C. § 2451 note, to study space activities and formulate an agenda for the U.S. civilian space program. The Commission is to submit to the President and Congress a long-range plan for civilian space activity.

Pursuant to Section 203(a)(1) of Public Law 98-361, the President is authorized to appoint 15 members to the Commission "selected from among individuals from Federal, State, and local governments, industry, business, labor, academia, and the general population who, by reason of their background, education training, or experience, possess expertise in scientific and technological pursuits, as well as the use and implications of the use of such pursuits." No more than three of the 15 may be Federal employees.

Dr. O'Neill is on leave from Princeton University. He is President and CEO of Geostar Corporation, a firm developing a commercial system to use satellites to aid navigation. Geostar has had and probably will have matters pending before the FCC.


Dr. O'Neill obviously has a direct commercial interest in space issues. I do not, however, view his role at Geostar as a bar to his appointment to the Commission. The statute looks to the appointment of individuals active in space research and the exploitation of space, and the agenda of the Commission is broad enough to attenuate any potential conflicts. In addition, the Commission is purely advisory, and does not engage in any regulatory activities.



I have reviewed the Personal Data Statement submitted by the above-named individual in connection with his prospective appointment to the JFK Center for the Performing Arts Board of Trustees. I have advised you orally that I have no objection to proceeding with this appointment. The President is authorized to appoint 30 general trustees to this board under 20 U.S.C. § 76h(a). Mr. Fryer satisfies the only statutory requirement for trustees, i.e., that they be citizens of the United States. The duties of the Board consist of maintaining and administering the Kennedy Center.

Mr. Fryer is a well-known producer of both theatrical productions and films, and is the artistic director of a theater group based in Los Angeles. Certainly conflicts could arise in the course of his duties, for example if the Kennedy Center were considering putting on one of Mr. Fryer's plays. Normally such questions would not be decided by the trustees, however, and Mr. Fryer could and should recuse himself should any situation of this sort arise.


Thank you for your letter of March 22, in which you discuss modified procedures for routine updating of investigations for NSC staff members.

SUBJECT: Appointments to the Commission
on the Bicentennial of the United
States Constitution

Pursuant to Section 4(a) of Public Law 98-101, 97 Stat. 719 (1983), the President is authorized to appoint 20 of the 23 members of the Commission (the Chief Justice, Speaker of the House, and President pro tempore of the Senate are appointed by statute). Of the 20 Presidential appointees, four are to be chosen from recommendations submitted by the Speaker, four from recommendations submitted by the President pro tempore, and four from recommendations submitted by the Chief.

Recommendations of the Speaker

- Lynne Cheney, Senior Editor of The Washingtonian, wife of Congressman Dick Cheney of Wyoming.
- Thomas Henry O'Connor, Professor of History at Boston College.
- William Joseph Green, Philadelphia attorney, former Congressman and Mayor of Philadelphia.
- Congressman Philip M. Crane (R-IL).

The only difficulty with these appointments involves the appointment of Crane, a sitting member of Congress. As you know, the President stated when he signed the bill establishing the Commission that "in view of the Incompatibility Clause of the Constitution, any member of Congress appointed by me pursuant to section 4(a) (1) of this Act may serve only in a ceremonial or advisory capacity." (This concern is distinct from the concerns surrounding the role of the Chief Justice, which did not involve the Incompatibility Clause but separation of powers more generally.)

Recommendations of the President pro tempore

- Harry M. Lightsey, Dean of the University of South Carolina School of Law.

- Edward P. Morgan, sole practitioner in Washington, D.C.
- Senator Ted Stevens (R-Alaska).
- Senator Wendell Ford (D-KY).

I have reviewed the Personal Data Statements submitted by Messrs. Lightsey and Morgan, and have no objection to proceeding with their appointments. I have received nothing from the Senators. They would be subject to the same limitations discussed above with respect to Congressman Crane.

Recommendations of the Chief Justice

- Charles Wiggins, U.S. Circuit Judge, Ninth Circuit.
- Cornelia Kennedy, U.S. Circuit Judge, Sixth Circuit.
- Herbert Brownell, Of Counsel to Lord, Day & Lord, former Attorney General.
- O.C. Tanner, founder and chairman of O.C. Tanner Company, attorney.

I have reviewed Personal Data Statements submitted by all of the foregoing and have no objection to the appointments. Service of sitting Federal judges does raise separation of powers concerns, but as those were overcome in appointing the Chief as Chairman I see no purpose to be served by raising them now.

Kirk has yet to submit a PDS. Of the others, some, such as Schlafly, will obviously be controversial. Siegan's writings on the Constitution advance a theory of economic liberty that will be controversial to many constitutional law scholars. Wright is an attorney for Tavoulareas in the controversial Tavoulareas v. Washington Post case. Ron Walker was a consultant in 1975 for Saudi Arabia. I telephoned him to alert him to the prohibitions of 18 U.S.C. § 219, and he advised that he was not now registered as a foreign agent and saw no likelihood that he would be in a position to register in the future.

In sum, we can proceed with the appointments of Cheney, O'Connor, Green, Crane, Lightsey, Morgan, Wiggins, Kennedy, Brownell, Tanner, Siegan, Biebel, Murphy, Schlafly, Walker, and Wright. We can add Senators Stevens and Ford if you wish to dispense with PDS's from them. Kirk should not be announced until he submits a PDS. Finally, there is still a remaining slot on which I have no information.
